What data do we collect?

GoT To Escape collects the following data:

- Personal identification information (Name, email address, phone number, etc.)

How do we collect your data?

You directly provide GoT To Escape with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.

How will we use your data?

GoT To Escape collects your data so that we can:

- Process your order, manage your account.
- Email you with special offers on other products and services we think you might like.

How do we store your data?

GoT To Escape securely stores your data on our secure Hosting Server

GoT To Escape will keep your data for indefinitely.

Marketing

GoT To Escape would like to send you information about products and services of ours that we think you might like.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop GoT To Escape from contacting you for marketing purposes.

What are your data protection rights?

GoT To Escape would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access - You have the right to request GoT To Escape for copies of your personal data. We may charge you a small fee for this service.

The right to rectification - You have the right to request that GoT To Escape correct any information you believe is inaccurate. You also have the right to request GoT To Escape to complete information you believe is incomplete.

The right to erasure — You have the right to request that GoT To Escape erase your personal data, under certain conditions.

The right to restrict processing - You have the right to request that GoT To Escape restrict the processing of your personal data, under certain conditions.

The right to object to processing - You have the right to object to GoT To Escape's processing of your personal data, under certain conditions.

The right to data **portability** - You have the right to request that GoT To Escape transfer the data that we have collected to another organization, or directly to you, under certain conditions.

What are cookies?

Cookies are text files placed on your computer to collect standard Internet log information and visitor behavior information. When you visit our websites, we may collect information from you automatically through cookies or similar technology.

How do we use cookies?

GoT To Escape uses cookies in a range of ways to improve your experience on our website, including:

- Keeping you signed in
- Understanding how you use our website

What types of cookies do we use?

There are a number of different types of cookies, however, our website uses:

- **Functionality** — GoT To Escape uses these cookies so that we recognize you on our website and remember your previously selected preferences. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.
- **Advertising** — GoT To Escape uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and your IP address. GoT To Escape sometimes shares some limited aspects of this data with third parties for advertising purposes. We may also share online data collected through cookies with our advertising partners. This means that when you

visit another website, you may be shown advertising based on your browsing patterns on our website.

How to manage cookies

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.
